Explanation:

To ensure that your app can interact with a Data Connect service instance, add code to your app to parse the connection information in the VCAP\_SERVICES environment variable.

The value of the VCAP\_SERVICES environment variable contains the information that your app needs in order to interact with the Data Connect service.

In the first REST method that your app calls, use the user ID and password from the VCAP\_SERVICES environment variable to authenticate by using HTTP basic access authentication. The first call returns an authentication cookie, which other REST calls from your app can use.

When you bind a service to your application Bluemix will add details about the service to an environment variable VCAP\_SERVICES. VCAP\_SERVICES allows your application to discover bound services and how to access the service.

User-provided services (private to an organization) can be created - accessed the same way as a Bluemix provided service.
